

# ***ALLED Lighting Fixtures • Five Year Warranty***

## ***FIVE YEAR LIMITED WARRANTY:***

*Appalachian Lighting Systems, Inc. (“ALSI” or “ALLED”) warrants this fixture with its components when properly installed and under normal conditions of use, to be free from defects in materials and workmanship for five (5) years from the date of original purchase. ALSI will at its discretion, repair or replace the fixture or any of its components. In the event ALSI determines a fixture is not repairable or no longer available, ALSI will replace it with an item of similar style and value and ALSI makes no other warranty.*

*Conditions of Warranty: This warranty does not cover the following; (1) Any fixture that is not distributed in the U.S.A. by ALSI. (2) Any fixture that is not purchased in the U.S.A. from an authorized dealer. If you are uncertain if a dealer is an authorized dealer, contact ALSI as listed below. (3) Any fixture or component on which the serial number has been defaced, modified or removed. (4) Damaged, deterioration or malfunction resulting from (a) accident, act of nature, abuse, misuse, neglect, unauthorized fixture repair, opening of, or modification of any component or failure to follow instructions for installation and maintenance supplied with the fixture, (b) repair or attempted repair by anyone not authorized by ALSI (c) any shipment of the fixture (claim must be presented to the carrier) (5) Use of the fixture outside the U.S.A. (6) Any labor costs, installation or removal costs, or shipping costs due to the failure of the fixture. (7) Lightning strikes or other power transients or surges.*

***THIS WARRANTY COVERS, AND ALSI IS LIABLE FOR, ONLY THAT WARRANTY COVERAGE AND DAMAGES SPECIFICALLY DETAILED ABOVE. EXCEPT AS MAY OTHERWISE BE REQUIRED BY LAW ALSI SHALL NOT BE LIABLE FOR INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, EVEN IF ALSI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE.
